I hereby make application for an official ballot to be voted by me at this election. I agree to return said ballot to the Chicago Election Board by the close of polls Election Day, and, if by mail, postmarked by Election Day to be counted if received within 14 days of Election Day. Under legal penalties provided by 10 ILCS 5/29-10, I certify all statements in this application are true.
